Referring to your query, we would like to confirm the position of Croatia regarding the holders of the Israeli Travel document in lieu of National Passport:

Nationals of the State of Israel, holders of a Travel Document in lieu of National Passport, **do not require a visa** for transit through or intended stays in the territory of the Republic of Croatia not exceeding 90 days in any 180-day period.

It is understood that the Israeli nationality of the holder is indicated in such a Travel Document.

The period of validity of the Travel Document must be valid for at least 3 months after leaving Croatia.

My name is Jane, and I represent ATLAS. At the moment, at the request of the Israelis, we are updating data on entry to different countries using Travel Document in Lieu of National Passport. It is a second passport and is issued exclusively to Israeli citizens who do not live in the country. This passport is also known as a Provisional Passport.

According to the visa agreement between Israel and Croatia, Israeli citizens who own a Darkon can visit the country without obtaining a visa. What are the rules of entry into your country for Israeli citizens with Travel Document in Lieu of National Passport?

We are looking forward to receiving a response to update the data on entry to Croatia with Travel Document in Lieu of National Passport.
