Re: Clarification of the order of entry of Israeli citizens with Travel Document in Lieu of National Passport

Hello,

With reference to your question, we inform you that, according to Annex No.1 to Government Decision No. 765 of 18 September 2014 on the approval of the list of travel documents accepted for the crossing of the state border of the Republic of Moldova by foreigners, the documents issued by the competent authorities of the State of Israel, accepted by the Republic of Moldova for crossing the state border are:

Ordinary passport

Diplomatic passport

Service passport

Travel document

Laissez-passer

Passport

Travel document for refugees (Convention relating to the Status of Refugees of 28 July 1951).

Travel document for stateless persons (Convention relating to the Status of Stateless Persons of 28 September 1954).

At the same time we inform you that, in accordance with the provisions of Law No. 257 of 01.11.2013 on third-country nationals who are required to hold a visa and third-country nationals who are exempted from the visa requirement when crossing the state border of the Republic of Moldova, citizens of the State of Israel as per Annex N.2 are exempted from the visa requirement. when entering, leaving or transiting through the territory of the Republic of Moldova.

We also inform you that for foreign citizens the conditions for entry into the Republic of Moldova are set out in Article 6 of the Law No. 200 of 16.07.2010 on the Regime of Foreigners in the Republic of Moldova, and the requirements for travel documents are described in Article 6¹.

At the same time, we inform you that in accordance with Law 215 of 04.11.2011, art. 17. Border guards have the right to request justification of the purpose of entry into the Republic of Moldova of foreigners, who are obliged to present the confirmatory documents provided for in the above-mentioned article depending on the purpose of travel.
