Good afternoon!

Thank you for your prompt response. There may have been some misunderstanding, so we want to clarify a few points, and also attach a photo of Travel Document in Lieu of National Passport to this letter.

1) Travel Document in Lieu of National Passport is the second foreign passport in Israel, and with it you can enter not only the territory of Israel, but also other countries (including EU countries).

2) According to official data, the entire European Union (except Malta and Iceland) recognizes Travel Document in Lieu of National Passport. The EU website states that the Netherlands recognizes this passport.

3) In addition, we have confirmation from you earlier that you recognized Travel Document in Lieu of National Passport .

The Travel Document in Lieu of National Passport or Provisional Passport (Darkon) is only recognized for exit or transit to return to Israel. The document cannot be used for entry, even with a visa.

My name is Jane, and I represent ATLAS. At the moment, at the request of the Israelis, we are updating data on entry to different countries using Travel Document in Lieu of National Passport. It is a second passport and is issued exclusively to Israeli citizens who do not live in the country. This passport is also known as a Provisional Passport.

According to the visa agreement between Israel and Netherlands, Israeli citizens who own a Darkon can visit the country without obtaining a visa. What are the rules of entry into your country for Israeli citizens with Travel Document in Lieu of National Passport?
