Good afternoon!

My name is Evgenia, and I represent ATLAS. At the moment, at the request of the Israelis, we are updating data on entry to different countries using Travel Document in Lieu of National Passport. It is a second passport and is issued exclusively to Israeli citizens who do not live in the country. This passport is also known as a Provisional Passport.

According to the visa agreement between Israel and Philippines, Israeli citizens who own a Darkon can visit the country without obtaining a visa and stay in it for 60 days. What are the rules of entry into your country for Israeli citizens with Travel Document in Lieu of National Passport?

We are looking forward to receiving a response to update the data on entry to Philippines with Travel Document in Lieu of National Passport.
