FW: Clarification of the order of entry of Israeli citizens with Travel Document in Lieu of National Passport

Dear Sir / Madam,

Based on the recent information obtained from the Turkish Ministry of the Interior, travellers in possession of State of Israel's "Travel Document in Lieu of National Passport" will be subject to the same immigration rules applied for the holders of State of Israel's passport (Darkon) upon entry to/exit from the Republic of Türkiye, as long as these holders of "Travel Document in Lieu of National Passport" prove that they are citizens/they have obtained citizenship of the State of Israel.

My name is Evgenia, and I represent ATLAS. At the moment, at the request of the Israelis, we are updating data on entry to different countries using Travel Document in Lieu of National Passport. It is a second passport and is issued exclusively to Israeli citizens who do not live in the country.

According to the visa agreement between Israel and Türkiye, Israeli citizens who own a Darkon can visit the country without obtaining a visa and stay in it for 90 days. What are the rules of entry into your country for Israeli citizens with Travel Document in Lieu of National Passport?

We are looking forward to receiving a response to update the data on entry to Türkiye with Travel Document in Lieu of National Passport.
