My name is Jane, and I represent ATLAS. At the moment, at the request of the Israelis, we are updating data on entry to different countries using Travel Document in Lieu of National Passport. It is a second passport and is issued exclusively to Israeli citizens who do not live in the country or became citizens less than a year ago. This passport is also known as a Provisional Passport.

According to the visa agreement between Israel and Namibia, citizens of Israel with a Darkon must obtain a Visa, after which they can enter the country. Can citizens of Israel with a Travel Document in Lieu of National Passport also apply for a Visa and enter your country?

We are looking forward to receiving a response to update the data on entry to Namibia with Travel Document in Lieu of National Passport.
